AERR report (annual distribution – late fall) – This is avail online via Sturgeon Public school division website, Trish encourages everyone to download a copy and read it. A lot of info re: survey w/ students and parents. These surveys bring to light where there may be perceived gaps in services or communication. There is also a dedicated section that discusses different Metis and Inuit populations.

Trish offered an apology and explanation for the late notification in the interrupted bus service today. In part there was a communication breakdown and some circuit

interferences that delayed the electronic notifications getting out. There will be some follow up at the board level. Normally the decision is made by the board to cancel buses, typically when it is -40. Otherwise, it is a parent driven decision and then up to the bus drivers to make a calculated decision it terms of the safety to have the buses on the road. Operations and maintenance department is responsible for clearing the bus lanes and parking lots, today was an anomaly. Operations and maintenance will be working into the night to ensure everything is cleared by tomorrow.

Trish asked about the grants that are avail to the school council to participated in workshop session (\$500). Still need clarification on how the remaining balance can be used. In the meantime, we will wait on a decision.
